

## PROJECT PARTNER ZOO AGREEMENT

### Preamble

Project: In-situ conservation project for Yellow-cheeked Crested Gibbons (*Nomascus annamensis*) in Kon Ka Kinh National Park, Vietnam, through Stiftung Artenschutz (SA) and Frankfurt Zoological Society (ZGF), commencing June 2016. This species is IUCN Red List endangered with less than 1,000 individuals estimated to be remaining in the wild.

Prime Sponsor: Anthony Sheridan, European Zoo Analyst, through profits from his books "Zooming in on Europe's Zoos" (ISBN 978-3-86523-087-4) and "Europas Zoos unter der Lupe" (ISBN 978-3-86523-110-9) and associated talks and publications.

Project Partner Zoos: Selected Zoos with good exhibits of *Nomascus gabriellae* or *Nomascus leucogenys* which are closely related to the Conservation Project species which is currently not on display in EAZA zoos. Selected Zoos must be member zoos of the EAZA Gibbon TAG or planning to be so in the immediate future.

Project Duration: The initial contract, signed in June 2016, is for two years (Phase 1) with an envisaged further two years (Phase 2), in the first instance.

Objective: Ensuring the stable recovery of the remaining population of *Nomascus annamensis* in Kon Ka Kinh national park, which holds the largest number of this species in Vietnam. The initial contract states the main activities, expected results and budgetary costs for Phase1.
